

## HOUSTON ROCKETS & VEVOR SWEEPSTAKES

In return for the opportunity to participate in the Houston Rockets & VEVOR Sweepstakes described herein (the “Sweepstakes”), Rocket Ball, Ltd., d/b/a the Houston Rockets (the “Houston Rockets”) and Sanven Technology Ltd. d/b/a VEVOR (the “Sponsor”) require your agreement to comply with and be bound by the terms and conditions set forth below (the “Official Rules”).

### OFFICIAL RULES

- 1. ENTRY PERIOD.** The Sweepstakes will begin on March 2, 2026, at 11:00 a.m. Central Time (“CT”) and end on March 9, 2026, at 11:59 p.m. CT (the “Entry Period”).
- 2. ELIGIBILITY. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.** Only legal residents of the United States who are 18 years of age or older as of the first day of the Entry Period are eligible to participate in this Sweepstakes, provided they live within the state of Texas or 150 miles of the Houston, TX city limits, excluding residents within 75 miles of either the Dallas, TX or San Antonio, TX city limits. Employees and immediate family members (spouses, parents, siblings, and children) of employees of the Houston Rockets, Clutch City Sports & Entertainment, L.P., Sponsor, the National Basketball Association (the “NBA”) and its member teams, NBA Properties, Inc., and each of their respective parents, subsidiaries, affiliates, directors, partners, officers, governors, employees, and agents are not eligible to enter. The Sweepstakes is void wherever prohibited or restricted by law.
- 3. ENTRIES. LIMIT OF ONE (1) ENTRY PER PERSON.** There are two (2) ways to enter the Sweepstakes (each, an “Entry”):
  - **Primary Entry Method:** To enter the Sweepstakes, Entrant must (1) click on the link ([www.rockets.com/VEVOR](http://www.rockets.com/VEVOR)) promoted by the Houston Rockets’ and Sponsor that directs Entrant to the entry form; and (2) complete the entry form by providing the requested information and clicking submit.
  - **Alternate Entry Method:** Alternatively, an Entrant may enter the Sweepstakes by sending an email to Avani Sharma ([avanis@rocketball.com](mailto:avanis@rocketball.com)) with the subject line “Houston Rockets & VEVOR Sweepstakes Entry” and include in the body of the email Entrant’s name, mailing address (no P.O. Boxes), email address, date of birth, and phone number.

Limit of one (1) Entry per person. Entries must be received during the Entry Period to be eligible. Any Entry received thereafter or not properly submitted will not be eligible to participate in the Sweepstakes. Any Entrant using multiple accounts to enter will be disqualified from the Sweepstakes and will not be eligible to win the Prize. Entries that contain, in the sole discretion of the Houston Rockets and/or Sponsor, any profane, obscene, vulgar, defamatory, libelous, or slanderous material will be disqualified. A person who timely submits a properly completed Entry in accordance with the procedures herein is considered an “Entrant.” **By submitting a properly completed Entry, each Entrant acknowledges that each Entrant has read, understands, and agrees to be bound by these Official Rules.**

- 4. SELECTION OF WINNERS.** Nine (9) winners (each, a “Winner”) will be selected at random from among all eligible Entries received. Winners will be notified on or about March 10, 2026, via email. By participating, each Entrant agrees to these rules and the decisions of the Houston Rockets and/or Sponsor, which shall be final and legally binding in all matters relating to this Sweepstakes. The Houston Rockets and/or Sponsor reserve the right to conduct a background check of each Entrant and to disqualify any Entrant, effective upon written notice, if such Entrant commits, or has at any time

committed, any act or becomes involved in, or has at any time been involved in, any situation or occurrence which act, situation, or occurrence tends in the sole opinion of the Houston Rockets and/or Sponsor to subject Entrant, the Houston Rockets and/or Sponsor or their affiliates to any ridicule, contempt, or scandal or which, in the sole opinion of the Houston Rockets and/or Sponsor or their affiliates, reflects unfavorably upon the Houston Rockets and/or Sponsor or their affiliates. **If any randomly-selected Winner cannot be contacted within forty-eight (48) hours after the first attempt, declines the Prize, or fails to claim the Prize, then such Winner will forfeit the right to be a Winner, and the Sponsor and/or Houston Rockets may select the replacement Winner from among all remaining eligible Entries.**

5. **PRIZE DESCRIPTION; ODDS.** Each Winner will receive one (1) VEVOR Portable Basketball Stand ([28-Inch](#)) (Approximate Retail Value “ARV”: \$65.00) (the “Prize”). All aspects of the Sweepstakes and Prize shall be determined by the Houston Rockets and/or Sponsor in their sole discretion, and any Prize shall be subject to all Houston Rockets and NBA rules, regulations, guidelines, policies, and restrictions. The Houston Rockets and/or Sponsor shall not be responsible for any expenses associated with any Prize, including but not limited to travel accommodations or transportation expenses. The odds of winning will depend on the number of eligible Entries received. Winners may not sell, assign, transfer, or substitute the Prize (or any portion of the Prize) or redeem the Prize (or any portion of the Prize) for cash value. Winners will be responsible for any federal, state, and local taxes associated with the Prize and for any expenses associated with the Prize. Winners may be required to sign, at the request of and in the sole discretion of Sponsor and/or the Houston Rockets, a Release, an Affidavit of Eligibility, and/or a Prize Acceptance Form in order to receive the Prize. The Houston Rockets and/or Sponsor reserve the right to substitute any Prize (or any portion of the Prize) with any prize of greater or equal value.
6. **LIMITATIONS ON LIABILITY.** Neither the Houston Rockets nor Sponsor shall be responsible for Entries that are incomplete, improperly submitted, stolen, misdirected, lost, late or damaged. All Entries become the property of the Houston Rockets and/or Sponsor and will not be acknowledged or returned. **By entering, each Entrant agrees to HOLD HARMLESS AND INDEMNIFY Sponsor, the Houston Rockets, Clutch City Sports & Entertainment, L.P., the NBA and its member teams, NBA Properties, Inc., and each of their respective partners, parents, subsidiaries, affiliates, directors, officers, governors, employees, and agents (the “Released Parties”) from any and all liability, damages, claims and causes of action (however named or described) with respect to or arising out of (a) Entrant’s participation in this Sweepstakes, (b) Entrant’s Entry or any registration material on any related website, (c) any typographical or other error in these Official Rules or (d) the receipt, participation in, or use of the Prize (or any portion of the Prize) or any replacement prize that may be awarded herein, including any travel associated with the Prize.**
7. **CONSENT OF USE.** Each Entrant hereby agrees and consents, without further authorization, compensation or remuneration of any kind, to the editing, modification, replication, publication and other use of the names, likenesses, photographs, voices, Entries and the like of each Entrant in any medium, whether now known or hereafter developed, including without limitation, the Houston Rockets and/or Sponsor’s website and in any and all advertising, promotions, and other publicity conducted by Sponsor, the Houston Rockets, the NBA and its member teams, NBA Properties, Inc., and each of their respective partners, parents, subsidiaries, affiliates, directors, officers, owners, governors, employees, and agents, except where prohibited by law. Notwithstanding the generality of the foregoing, each Entrant further assigns all rights Entrant may have over their Entry to the Houston Rockets and/or Sponsor without further authorization, compensation, or remuneration of any kind.

8. **RULES.** All decisions as to these Official Rules and interpretations thereof are exclusively within the sole discretion of the Houston Rockets and/or Sponsor and may be changed from time to time without notice. The Houston Rockets and/or Sponsor reserve the right to cancel or modify the Sweepstakes at any time without notice.
9. **DISPUTES.** This Sweepstakes shall be governed by and construed in accordance with the laws of the State of Texas, without regard to principles of conflicts of laws. **EACH ENTRANT HEREBY WAIVES ANY AND ALL OBJECTIONS TO JURISDICTION AND VENUE IN THOSE COURTS AND SUBMITS TO THE JURISDICTION OF THOSE COURTS.** Should any current or future dispute, claim or cause of action related to this Sweepstakes arise between the Entrant and the Houston Rockets and/or Sponsor, a written notice (a “Dispute Notice”) must be sent with the following information: (i) name, contact information (address, telephone number, and email address), and account information if applicable; (ii) a description of the nature and basis of the dispute; and (iii) a description of the nature and basis of the relief sought, including a calculation for it. If the Entrant has a dispute, the Entrant shall send the Dispute Notice to [generalcounsel@rocketball.com](mailto:generalcounsel@rocketball.com). The Entrant, the Houston Rockets, and/or Sponsor agree to make a good-faith effort to resolve the dispute for at least sixty (60) days (the “Negotiation Period”) following receipt of the Dispute Notice. If the parties cannot resolve the dispute within the Negotiation Period, the dispute shall be resolved by binding arbitration. The arbitration shall be conducted in Houston, Texas, in accordance with the then-current Judicial Arbitration and Mediation Services (“JAMS”) Comprehensive Arbitration Rules & Procedures before an arbitrator selected by mutual agreement of the parties, if possible. The JAMS Rules shall govern the payment of all arbitration fees. Notwithstanding the foregoing, the Houston Rockets will consider a request to reimburse Entrant’s portion of the arbitration fees upon a showing of hardship in its sole discretion and assuming Entrant does not qualify for a waiver from JAMS. All issues are for the arbitrator to decide **except** the following items (which are for a court of competent jurisdiction to decide): (i) issues that are specifically reserved for a court; (ii) issues related to the scope and enforceability of the arbitration provisions; and (iii) whether a dispute can or must be brought in arbitration. **TO THE FULLEST EXTENT PERMITTED BY LAW, THE ENTRANT, THE HOUSTON ROCKETS, AND/OR SPONSOR AGREE THAT ALL DISPUTES SHALL BE ARBITRATED ON AN INDIVIDUAL BASIS AND WAIVE ANY RIGHT TO LITIGATE IN COURT OR ARBITRATE ANY CLAIM AS A CLASS ACTION, REPRESENTATIVE ACTION, OR CLASS ARBITRATION. TO THE FULLEST EXTENT PERMITTED BY LAW, THE ENTRANT, THE HOUSTON ROCKETS, AND/OR SPONSOR WAIVE THE RIGHT TO A JURY TRIAL. IF THE ENTRANT DOES NOT CONSENT TO THIS CLAUSE, THE ENTRANT MUST NOT ENTER THE SWEEPSTAKES.** Entrant has the right to opt out of arbitration under these Sweepstakes by sending the Houston Rockets a personally signed, written notice of Entrant’s decision to opt out via email to [generalcounsel@rocketball.com](mailto:generalcounsel@rocketball.com) within the earlier of the Sweepstakes notification date or thirty (30) days after entering the Sweepstakes. Such an opt out will not opt Entrant out of an arbitration agreement Entrant might otherwise have with the Houston Rockets and/or Sponsor. Under no circumstances will Entrant be permitted to obtain any punitive, incidental, special, consequential, or other damages, including without limitation lost profits (collectively, “Special Damages”) to an Entrant, and Entrant hereby waives all rights to claim Special Damages and all rights to have such damages multiplied or increased.
10. **FORCE MAJEURE.** Neither the Houston Rockets nor Sponsor shall be responsible for the failure or interruption of any website, webpage, or social media platform mentioned herein (including those of the Released Parties), any email server, or the cancellation or postponement of a Houston Rockets game

or any drawing for any reason including, but not limited to, equipment failure or malfunction, electrical service interruption, pandemic (e.g. COVID-19) or any act of God. In addition, in the event that the Houston Rockets and/or Sponsor are prevented from continuing with the Sweepstakes by any event beyond its control, including, but not limited to, fire, epidemic, pandemic, virus, disease, bacteria, flood, hurricane, earthquake, explosion, labor dispute or strike, act of God or public enemy, communications or equipment failure, utility or service interruptions, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared), interference with the Sweepstakes by any party, or any federal, state, or local government law, order, or regulation, order of any court or jurisdiction, or other cause not reasonably within the control of the Houston Rockets and/or Sponsor, the Houston Rockets and/or Sponsor have the right to modify, suspend or terminate the Sweepstakes.

- 11. PRIVACY AND MARKETING DISCLAIMER.** By entering the Sweepstakes, Entrant agrees to be bound by the NBA's privacy policy located here: <https://www.nba.com/privacy-policy>; and Sponsor's privacy policy located here: <https://www.vevor.com/pages/privacy-policy>. Entrant agrees to receive communications from Sponsor and/or Houston Rockets, subject to opting out when Entrant so desires. If Entrant provides a cell phone number, then Entrant consents to be contacted by Sponsor and/or the Houston Rockets using an auto-dialer for marketing purposes.
- 12. PUBLICITY.** Entrant hereby grants to the Released Parties, with no obligation to compensate Entrant, or any other person in any way, the right at any time to publish, reproduce, modify, display, distribute, license or otherwise use, commercially or otherwise (including in connection with any publicity, marketing and promotion), in any media now existing or later developed, Entrant's name, Entry, and any photographs, videotapes, motion pictures, recordings, or other record of Entrant. Entrant understands that Entrant's name, photograph or likeness may be modified, copied and distributed by means of various media. Entrant may not use the intellectual property of the Released Parties (including the stylized marks or logos of the Houston Rockets) without the express written permission from the Released Parties.
